The refereed proceedings of the First Iberian Conference on Pattern Recognition and Image Analysis, IbPria 2003, held in Puerto de Andratx, Mallorca, Spain in June 2003. The 130 revised papers presented were carefully reviewed and selected from 185 full papers submitted. All current aspects of ongoing research in computer vision, image processing, pattern recognition, and speech recognition are addressed.

Il volume si occupa dell'istituto dell'amministrazione di sostegno, nuova disciplina introdotta nel codice civile con la legge n. 6 del 2004, che ha istituito una nuova figura (quella dell'amministratore di sostegno, appunto) accanto agli altri istituti a tutela delle persone incapaci (interdizione, inabilitazione, incapacità naturale). Secondo quanto previsto dalla legge di riforma, infatti, tutti i soggetti che, a causa di una infermità o di una menomazione fisica o psichica si trovino nell'impossibilità (anche parziale o temporanea) di provvedere ai propri interessi, possono ora essere assistiti da un amministratore di sostegno, appositamente nominato dal giudice. Sono affrontati, tenendo conto della recente normativa e della giurisprudenza formatasi in materia, tutti gli aspetti caratterizzanti questo rivoluzionario istituto, a partire dal procedimento di nomina ad amministratore, per giungere agli effetti, alla responsabilità, fino alle possibili interferenze con altri istituti di diritto privato. All'interno è possibile trovare una selezione di casi che rappresentano una summa delle questioni di maggiore interesse, selezionate dall'autore, accompagnate da una soluzione data tenendo conto della normativa in materia e dalla più recente giurisprudenza.

This substantial volume comprises almost fifty Semitic and Assyriological studies dedicated to Pelio Fronzaroli, professor of Semitic philology at the University of Florence, written by colleagues and pupils.

This volume presents the second half of the proceedings of the Sixth International Conference of the International Plutarch Society (2002). The selected papers are divided by theme in sections concentrating on statesmen and statesmanship in Plutarch's Greek and Roman Lives. The volume bears witness to the ongoing, wide-ranging interest in Plutarch's biographies.

In contrast to the other synoptic evangelists the author of Matthew proceeded differently in many respects. Why did he modify the text so much and arrange ten miracle narratives one after the other at one stretch with minor interruptions? Why did he place the so-called «miracle chapters» immediately after the Sermon on the Mount. Why did he enclose them between two summary statements on either side? These are only some of the unanswered questions about chapters 8 and 9 of Matthew's Gospel. Beginning with Aristotle's theory of the drama or tragedy, the author suggests that the way the evangelist has reworked and reorganized the miracle narratives is similar to the structure of the classic drama. By discovering the narrative strategies and the discourse aspect, we are able to demonstrate how each episode corresponds to the different moments of a plot such as the initial situation, inciting moment, complication, climax with suspense and finally resolution and denouement.

Un rasta va alla ricerca dei segreti della sirena tra le rocce della fortezza veneziana di Monenvassia; il marinaio Mimis decide di porre fine all'angoscia che gli procurano i sofismi del Maestro; Uninnocua amicizia entra nella vita di un marito geloso. In recent years, funding for the conservation of cultural heritage has become increasingly difficult to obtain, and this trend shows no sign of changing significantly in the foreseeable future. The twelfth triennial meeting of the International Committee for the Conservation of Mosaics, held in Sardinia in October 2014, focused on the theme of cost, broadly considered, relating specifically to the preservation and presentation of the world's mosaic heritage. This volume contains the written versions of the lectures delivered by the participants of the Colloquium Origenianum Nonum held in Pecs (Hungary, 29 August - 2 September 2005). The main topic of the conference was Origen and the religious practice of his time. Here 49 scholars from some 18 countries publish their newest findings on the greatest and most influential Christian thinker before Augustine, who laid the foundation of the Biblical textual studies, created systematic theology, and was regarded as an authentic spiritual leader of Christianity.
