"The People Are King traces the transformation of Andean communities under Inca and Spanish rule. The sixteenth century Spanish resettlement policy, known as Reducción was pivotal to this transformation. Modeled on the Spanish ideal of República (self-government within planned towns) and shared sovereignty with their monarch, Spaniards in the Viceroyalty of Peru forced Andeans into resettlement towns. Andeans turned the tables on forced resettlement by making the towns their own, and the center of their social, political, and religious lives. Andeans made a coherent life for themselves in a complex process of ethnogenesis that blended preconquest ways of life (the ayllu) with the imposed institutions of town life and Christian religious practices. Within these towns, Andeans claimed the right to self-government, and increasingly regarded their native lords, the caciques, as tyrants. A series of microhistorical accounts in these repúblicas reveals that Andeans believed that commoner people,

collectively called the *común*, could rule themselves. With both Andean and Spanish antecedents, this political philosophy of radical democracy was key to the Great Rebellion of the late eighteenth-century. Rather than focusing on well-known leaders such as Tupac Amaru, the book demonstrates through commoner rebels' holographic letters that it was commoner Andean people who made the late eighteenth-century a revolutionary moment by asserting their rights to self-government. In the final chapter the book follows the commoner-lead towns of the Andes from the era of independence into the present day of the Plurinational State of Bolivia. *Ayllu, Reducción, ethnogenesis, Peru, Bolivia, cacique, Tupac Amaru, comunero, revolution, microhistory*--

Photographs of Earth from space clearly show evidence of such an explosion. Such gratifying corroboration of audacious conclusions has been even swifter for *The Lost Realms*. In the relatively short interval between the completion of the manuscript and its publication, archaeologists, linguists, and other scientists have offered a "coastal theory" in lieu of the "frozen trekking" one to account for man's arrival in the Americas--in ships, as this volume has concluded. These experts have "suddenly discovered 2,000 years of missing civilization" in the words of a Yale University scholar--confirming this book's conclusion--and are now linking the beginnings of such civilizations to those of the Old World, as Sumerian texts and biblical verses. History of the Inca Realm is a classic work of ethnohistorical research that has

been both influential and provocative in the field of Andean prehistory. Maria Rostworowski uses a great variety of published and unpublished documents and secondary works by Latin American, North American, and European scholars to examine topics such as the mythical origins of the Incas, the expansion of the Inca state, the political role of women, the vast trading networks of the coastal merchants, and the causes of the disintegration of the Inca state in the face of a small force of Spaniards.

One of the earliest chronicles of the Inca empire was written in the 1550s by Juan de Betanzos. Although scholars have long known of this work, only eighteen chapters were actually available until the 1980s when the remaining sixty-four chapters were discovered in the collection of the Fundación Bartolomé March in Palma de Mallorca, Spain. *Narrative of the Incas* presents the first complete English translation of the original manuscript of this key document. Although written by a Spaniard, it presents an authentic Inca worldview, drawn from the personal experiences and oral traditions told to Betanzos by his Inca wife, Doña Angelina, and other members of her aristocratic family who lived during the reigns of the last Inca rulers, Huayna Capac Huascar and Atahualpa. Betanzos wrote a history of the Inca empire that focuses on the major rulers and the contributions each one made to the growth of the empire and of Inca culture. Filled with new insights into Inca politics, marriage, laws, the calendar, warfare, and other matters, *Narrative of the Incas* is essential reading for everyone interested in this ancient civilization.

animal and human sacrifices and buried human trophy heads and the mummified remains of Aymara kings in lavish religious pageants. So impressive was the legacy of Tiahuanaco that the Inca rulers claimed descent from the Aymara kings more than 500 years after the empire's mysterious catastrophic demise. Kolata deciphers the mysteries of the ancient monuments, from the massive Akapana pyramid, the symbol of sacred mountains, and of fertility and abundance, to the imposing archway known as the Gateway of the Sun, among the most exquisite artistic monuments of the ancient Americas. And he takes us into the contemporary world of the Aymara as well, where shamans recite the names of ancestral spirits in a hypnotic protocol of remembrance and homage to Lady Earth and Lord Sky.
