The work, a comprehensive documentation of the chequered history of the trade union movement in Kerala, is based on published and unpublished sources and reminiscences of senior union leaders. The book traces the early phase of the union movement in Alappuzha and its rapid spread and growth across the state. The close networking relationship between trade union centres and political parties is also critically traced in the book and it throws light on the emergence of pro-labour policies of the State, division and fragmentation of the union movement in recent times and public's changing perception of trade unions in society. In few Asian countries is organized labor so important an economic and political factor as in contemporary Indonesia, and in few countries of the world has it been so politicized. Yet, thus far very little serious research and writing has been concerned with the Indonesian trade unions. In addition, he was from 1951 to 1956 Chairman of the Political Bureau of the Labor Party. The national trade union is the dominant institution in the American labor movement. In this book the author analyzes its emergence and development in the latter half of the nineteenth and early part of the twentieth centuries. It was during this period that the labor union as a nationwide organization achieved dominance over other labor institutions. The author discusses first the historical factors affecting trade union development. The body of the book covers the various stages in the evolution of union membership, organization, and government. An integral part of these chapters is a comparison of the national union movement in America and in Great Britain. The book concludes with a presentation of the interrelationships of the unions, and with a discussion of their relations with employers.

Cole saw the trade unions as being critical to progress, but to realise their role they needed to change and the issue of trade union structure therefore became fundamental. He considered in this volume that trade union structure was a central problem of the labour movement – he described British trade unionism as a movement bereft of ideas and policy. He discusses the evolution in the trade unions to cover not only wages and working conditions but the organisation and control of industry.
